## Annual Report 2016

### Hello Friends,

The Farmington River Coordinating Committee continues to steward and celebrate our beloved river. FRCC's mission is to implement and uphold the Upper Farmington River Management Plan, (which we updated in 2011 to accommodate changing conditions), to advocate and educate for protection of the river and its environs, to promote its values (ecological, historical, recreational and economic), and to resolve problems by facilitating agreement and cooperation among the many stakeholders in these efforts.

FRCC includes volunteer representatives from the participating towns of Barkhamsted, Canton, Colebrook, Hartland and New Hartford, as well as representatives from CT DEEP, Farmington River Watershed Association, Metropolitan District Commission, National Parks Service and the Farmington River Anglers Association. We also have many project partners and fellow stakeholders including the city of Torrington, town of Winchester, Northwest CT Community College and Northwest Conservation District.



In recent years we have seen ramped-up challenges to the health of the river and the watershed, including large increases

in the number of recreational users, development pressures, the spread of invasive non-native species, political upheaval and extreme climate fluctuations. FRCC has risen to these challenges and we continue, with your help, to find ways to protect the "outstandingly remarkable values" that make the Farmington River special.

Some highlights of our 2016 activities include:

- Actions on the Still River watershed addressing causes of pollution and bacterial events flowing down to the River;

- Continuing to improve and develop our River Stewards program;
- Continuing to identify, evaluate and interdict Non-native species invasions;
- Water quality monitoring, and survey of culverts on upper FR tributaries for fish/wildlife passage issues;
  - Sponsoring the creation and display of the Farmington River Quilt;
- Updating and improving our websites and expanding our media presence;
- Protecting sensitive land parcels, and supporting local groups and communities with projects that support our mission;

- Awarding scholarships to students to further their education in fields related to our mission.
